
# 2023 LICENSE EXPIRATIONS — Enrolled ON OR AFTER June 30, 2023 Steps to Complete Continuing Education

- 1. Enroll in the Continuing Education course and receive your login information.
- Login to the test site at <u>www.accreditedschools.com</u> and select "Online Testing."
- 3. Read through the Examination Procedures and select "Click Here to Login to the Test Site."
- **4.** For additional information, the General Information Page is found starting on Page 2 of this document.
- 5. Study the reading material in PDF format. The PDF is accessible on your online testing account under the tab, "Reading Material." Click on "License Renewal Text for Enrollments ON OR AFTER June 30, 2023."
- **6.** Complete the quizzes. If you have problems disabling pop-up blockers, please see the directions on the next page.
- 7. After completing the quizzes and it is at least the third day from enrollment, you could attempt a final exam. The time parameters for testing are posted below, but all exams require a 70% or higher to pass. Please remember, only one final exam per day is allowed.

- Choose Options
- Select the Content tab
- Uncheck the box next to "Block pop-up windows"

#### Microsoft Edge

- Click on the More button ( . . . )
- Clcik "Settings."
- Scroll down and click "View Advanced Settings."
- Click the slider under the heading that says "Block pop-ups"

#### **Internet Explorer**

- Click on the settings/gear/cog button
- Go to Internet Options
- Click on Privacy
- Uncheck Turn on Pop Up Blocker

Temporarily disable pop-up blockers by clicking and holding the control key on your keyboard while clicking on "Start Test."

#### **COURSE DESCRIPTIONS**

3 Hours Agency

Textbook Title: Agency

Author: Bryan Church, 36 Pages (2015), DRE Sponsor # 4183

The course examines the Civil Code in light of the duties an agent has to his or her principal. The Agency Disclosure Form is examined in regard to disclosure requirements for single agency and dual agency. Fiduciary duties and an agent's duty of honest and fair dealing are also discussed. Two important appellate court cases are examined and discussed as they relate to an agent's duties to his or her principal.

#### 3 Hours Ethics, Professional Conduct, and Legal Aspects of Real Estate

**Textbook Title: Ethics** 

Author: Bryan Church, 33 Pages (2015), DRE Sponsor # 4183

The course examines Business and Professions Code Section 10176 that relates to agent ethical duties to his or her principal. Areas covered include misrepresentation, false promise, dual agency, commingling, secret profits, citations, undisclosed purchase options, fraud, dishonest dealing, moral turpitude, material false statements, negligence, incompetence, broker not exercising reasonable supervision over salespersons, commissioner's actions, and other ethical considerations under the law. In addition, the course covers one appellate court case that relates to ethics in today's brokerage market.

#### 3 Hours Trust Fund Handling

Textbook Title: Trust Fund Handling

Author: Bryan Church, 38 Pages (2015), DRE Sponsor # 4183

The course examines the difference between trust funds and non-trust funds, why you may need a trust account, trust fund handling requirements, identifying owner(s) of trust funds, trust fund bank accounts and their general requirements, interest-bearing accounts, commingling, trust fund liability, shortages and overages, accounting records, other accounting systems and records, reconciliation, documentation requirements, and an examination of a sample transaction.

#### 3 Hours Risk Management

Textbook Title: Risk Management

Author: Bryan Church, 36 Pages (2015), DRE Sponsor # 4183

The course examines the basic concept of risk management, standards of care, contract preparations, property condition, property ownership, trust fund handling, material facts, Real Estate Settlement Procedures Act (RESPA), conflicts of interest, negligent advice, agency duties, dual agency, secret profits, ostensible agency, gratuitous agency, patently frivolous offers, contracts, and damages. The course also examines the probability of risk, common areas of risk, RESPA violations, license activity likely to contribute to risk, and includes fair housing issues. Practical examples of high-risk areas are discussed, including fraud, misrepresentation, nondisclosure, concealment of material facts, and unlicensed assistants. Risk reduction techniques are examined for brokers, salespersons, and broker-salesperson agreements. Lastly, risk management and the consumer are discussed, including fiduciary responsibilities and legal obligations.

#### 3 Hours Management and Supervision

Textbook Title: Management and Supervision

Author: Bryan Church, 56 Pages (2015), DRE Sponsor # 4183

The Management and Supervision course is comprised of topics related to broker management and supervision of salespersons and broker associates. Topics include establishing policies, rules, and procedures including systems to review, inspect, and manage brokerage offices; supervision of all transactions involving real estate licensees; retaining and reviewing documents which may have a material effect upon the rights or obligations of a party in a transaction; proper filing, storage, and maintenance of documents required under B&P §10148 and Commissioner's Regulation 2729 and 2729.5; proper handling of trust funds according to B&P §10145 and Commissioner's Regulations 2830 through 2836; advertising of any service for which a license

is required pursuant to B&P §10140.6, §10159.5, §10235, §10235.5 and §10236.4; familiarizing salespersons with the requirements of federal and state laws relating to the prohibition of discrimination; regular and consistent reports of licensed activities of salespersons; role and responsibilities of branch or division managers pursuant to B&P §10164, including salespersons acting as branch or division managers, responsibilities of a broker to ensure salespersons working as "teams" are in compliance with B&P §10159.7; and supervision over restricted licensees.

#### **15 Hour Consumer Protection**

Textbook Title: Real Estate Update

Author: Bryan Church, 136 Pages (2023), DRE Sponsor # 4183

The course covers topics relevant to single-family investment properties which include a look at real estate market bubbles; real estate market timing and how it affects investment decisions; why real estate is a good investment vehicle versus other investment types; characteristics of existing single-family homes—a look at physical issues such as roofs, HVAC, and other potential problem areas; characteristics of condominiums; neighborhoods—how they grow and develop; and distressed properties, including short sales, trustee's sales, and real estate owned properties.

#### **13 Hour Consumer Protection**

Textbook Title: The Next Level of Real Estate Version II Author: Bryan Church, 112 Pages (2023), DRE Sponsor # 4183

The course examines long-term single-family investments vs flipping for short-term profits; buying properties in the path of progress; new single-family homes—inside and outside the subdivision; real estate income properties including investor motivations and concerns; real estate economics for the investor; and real estate investment taxation.
